Environmental Strategies

- SDGs is the core part of "Transforming our world: the 2030 Agenda for Sustainable Development" adopted at the United Nations Sustainable Development Summit on 25 September 2015.
- This UN agenda starts as "Preamble" and follows as "Declaration", "Sustainable Development Goals and targets" (writes down all 17 goals and 169 targets), "Means of implementation and the Global Partnership", and "Follow-up and review".
- It is highlighted "Voluntary" and "Nationally-led" in the chapter of "Follow-up and review". It also stipulates that the follow-up and review at global level will be done at "High Level Political Forum (HLPF)".
- Voluntary National Reviews (VNRs) are set as plenary session of HLPF since 2016 and Government of Japan reported her VNR report in the year of 2017.

VOLUNTARY NATIONAL REVIEWS

Voluntary National Reviews Database

As part of its follow-up and review mechanisms, the 2030 Agenda for Sustainable Development encourages member states to "conduct regular and inclusive reviews of progress at the national and sub-national levels, which are country-led and country-driven" (paragraph 79). These national reviews are expected to serve as a basis for the regular reviews by the high-level political forum (HLPF), meeting under the auspices of ECOSOC. As stipulated in paragraph 84 of the 2030 Agenda, regular reviews by the HLPF are to be voluntary, state-led, undertaken by both developed and developing countries, and involve multiple stakeholders.

The voluntary national reviews (VNRs) aim to facilitate the sharing of experiences, including successes, challenges and lessons learned, with a view to accelerating the implementation of the 2030 Agenda. The VNRs also seek to strengthen policies and institutions of governments and to mobilize multi-stakeholder support and partnerships for the implementation of the Sustainable Development Goals.


This online review platform is dedicated to compiling information from countries participating in the voluntary national reviews of the High-level Political Forum on Sustainable Development.

Handbook for the preparation of Voluntary National Reviews (VNRs)

- ◆UN Department of Economic and Social Affairs (DESA) summarizes review process and way of writing VNRs report including table of contents into a handbook annually.
- ◆This handbook includes not only reviewing Goals, but also "integration of SDGs into policies", "no one will be left behind", "integration of the economic, social and environmental dimensions".
- ◆Participation of multi-stakeholders is highly recommended.

What is VLR?

- Voluntary Local Review of SDGs
- VLR was firstly recognized at HLPF2018 in July 2018, New York when Mr. Kitahashi (Mayor of Kitakyushu City) launched VLR reports for City of Kitakyushu, City of Toyama, Town of Shimokawa besides City of New York.
- Mr. Suzuki (Mayor of Hamamatsu City) also launched her VLR report for City of Hamamatsu at SDGs summit (once a four years) in Sep 2019 in New York.
- Major Urban Forums start to includes VLR sessions.
- UN DESA organized an online VLR workshop in June 2020.
- VLR is now globally recognized as the way to report the progress of SDGs at local level.



IGES SDGs project, "Aspiration to Action," will examine and suggest essential "means of implementation (MOI)" so that global SDGs can be put into action through active engagement with various stakeholders and partners.

Sustainable Development Goals Reports on Cities

 Launch of the World-First Voluntary Local Reviews (VLRs) on Shimokawa, Toyama, and Kitakyushu

16 July—IGES is pleased to announce the launch of several Sustainable Development Goals (SDGs) / Voluntary Local Review (VLR) Reports today on the sidelines of the 2018 UN High Level Political Forum held in New York. The VLR reports document the efforts of three local authorities in Japan working to advance the SDGs—namely, Shimokawa Town (Hokkaido), Toyama City (Toyama Prefecture), and Kitakyushu City (Fukuoka Prefecture), which led to their selection as "SDGs Future Cities" by the Japanese government in June 2018.

The reports, jointly written with IGES, comprise some of the first SDG reporting carried out by local governments anywhere in the world. All reports are structured around the "Handbook for the Preparation of Voluntary National Reviews: 2018 Edition", taking into account specific characteristics and the level of progress on SDG initiatives in each respective city. While all cities recognise the importance of engaging in the SDG agenda, many are still working to find ways to adapt the Goals into their local context with regard to implementation and monitoring. These reports seek to contribute to the sharing of good practices on the SDGs between local authorities, illustrating how three Japanese cities are driving action on the SDGs both in terms of policy and planning.





1 Introduction

(1) Significance of the 2030 Agenda

In today's global economy where people, goods and capital move world-wide, global issues such as climate change, natural disasters and infectious diseases often occur across the border one after another, hampering economic growth and causing severe impacts on social (ellipsis)

The Government of Japan will proactively participate in and contribute to the global follow-up and review process of the implementation of the 2030 Agenda through participation in the UN High-level Political Forum on Sustainable Development (HLPF). For the HLPF's Voluntary National Review (VNR), periodic reviews will be conducted at the appropriate timing. The active implementation of Voluntary Local Review (VLR), in coordination with local governments, will also be encouraged. In addition, Japan will cooperate with the STI Forum and contribute to the formulation of the STI for SDGs roadmap implemented by the United Nations.

Review of the Implementation Guiding Principles will be carried out continuously at least every four years in accordance with the UN SDG summit cycle. At that time, the review will be conducted with the participation of a wide range of stakeholders, just as revision of this Implementation Guiding Principle was.

Summary by the President of the Economic and Social Council of the high-level political forum on sustainable development convened under the auspices of the Council at its 2020 session

Introduction

The high-level political forum on sustainable development under the auspices of the Economic and Social Council convened from 7 to 16 July 2020, in a virtual format due to the COVID-19 pandemic. It included a three-day ministerial segment, from 14 to 16 July 2020.



Asia-Pacific Regional Guidelines On Voluntary Local Reviews

As part of its follow-up and review mechanisms, the 2030 Agenda encourages member States to "conduct regular and inclusive reviews of progress at the national and subnational levels, which are country-led and country-driven. As part of this review, starting in 2016, countries have presented their Voluntary National Reviews to the High-Level Political Forum on Sustainable Development. Inspired by the VNRs, local and regional governments are increasingly engaging in their own subnational reviews - the Voluntary Local Reviews (VLRs), which have proven useful for cities and regions to foster SDG localization and demonstrate local governments' capacity and commitments.

Although gaining in momentum, the VLR process does not have any official status as part of the formal follow-up and review processes hosted by the UN. There exists no specific template or official format that cities can follow if they choose to undertake a VLR. Developed in partnership with the Penang Platform for Sustainable Urbanization, the Asia-Pacific Regional Guidelines on Voluntary Local Reviews builds on existing resources and provides practical tools, checklists, and templates that local governments and other stakeholders can use when reviewing local progress against the SDGs. The content is designed to provide cities with context regarding the 2030 Agenda as well as guidance specific to the region to help them decide where to start, how to start and what to keep in mind when conducting a VLR.




